Education and Training Scholarship

Sponsoring Agency: World Plumbing Council

Description: One time scholarship for an individual involved in the Plumbing

Industry wishing to visit a country for the purposes of researching

and furthering plumbing training and methodologies.

Purpose – consistent with the World Plumbing Council (WPC) objective of promoting and assisting Plumbing Industry education and facilitating international recognition of competencies and standards, it wishes to:

- Facilitate an exchange of people involved in the Plumbing Industry to expose them to different techniques, new innovations and training systems
- Obtain information on the approach taken to the Plumbing Industry in different countries relative to the health and environmental aspects of plumbing
- Stimulate interest in the Plumbing Industry
- Recognise innovative research
- Promote its publications "Health Aspects of Plumbing" and "Environmental Aspects of Plumbing"
- Provide an opportunity to live and work in the cultures of the host countries therefore
 providing increased career opportunities, the chance to learn another language, develop
 friendships and increase global awareness of the contribution of plumbing to our society.

Some broad types of activities that may be of interest include:

- Regulatory training and education versus technical training
- Identification of emerging training needs
- Training and Education for environmental sustainability issues, systems, etc
- The importance of water efficiency to the Plumbing Industry (in chosen country)
- What can we learn about plumbing and health (in chosen country)?
- How does the training or lack of training affect the public health (in chosen country)?



Value: Up to a maximum of USD\$10,000.

Eligibility Requirements: The successful candidate will need to demonstrate an involvement

in the Plumbing Industry education and training in their own

country.

Requirements:

You will need to fill out the attached application form and submit it to the Secretariat.

- Your application will need to include at least two references and a letter of support from your employer or employers in your home country
- Applications must be submitted in an electronic format and submitted by email.
- The WPC Executive Board will appoint a Panel to assess all applications and make recommendations with an announcement of the successful applicant being made no later than 30 October 2017. Panel members who are members of the same organisation as an applicant will not be involved in considering that application.
- After completing their program, applicants will be required to provide a written report on the training system, standards, technology and other issues relating to their findings from the country or countries in which they have visited as part of their travel. This report should include clear recommendations relative to the Plumbing Industry arising out of the visit undertaken. This report must be a minimum of 7,500 words plus photos, charts, etc. with a short (500 word) Executive Summary for use as a communiqué. Some of the topics to be included in the report;
 - What did you learn?
 - How does what you learnt relate to the "Health Aspects of Plumbing?"
 - How does what you learnt relate to the "Environmental Aspects of Plumbing?"
 - How do you expect to use what you learnt for the benefit of training in your home country?
 - Were you able to impart some of your training and education skills to your hosts?
 - How did they benefit?
- Funding will be provided to cover approved travel, accommodation, subsistence and incidental costs supported by receipts up to a maximum of USD\$10,000
- Applicants may be expected to attend industry meetings and participate in photographs and publicity for the program and sponsoring organizations
- Successful applicants will be required to have completed their program and presented their report no later than 31 July 2018 in the year of the travel associated with their Scholarship.
